Please note: All orders are FOB Alectro Warehouse. Goods in transit are at the customer's risk. Damage Insurance is automatically included on all goods despatched by a Alectro nominated courier. A small charge to cover this insurance is included in your freight bill. If no freight charge is levied because goods are picked up by the customer or the customers nominated courier, the goods will NOT be insured by Alectro. Should a claim be made for damage to, or loss of goods in transit, customer is to pay the insurance companies excess fee of \$250 and any other costs associated with the claim. Title/Ownership

Ownership of Goods supplied by Alectro to the purchaser will remain with Alectro and not pass to the purchaser until payment in full for invoices raised is received and cleared by our bank. Until such time the purchaser must store the Goods in a manner that clearly shows property in the Goods, belongs to Alectro and the purchaser will hold the product in a fiduciary capacity as bailee. Upon non-payment within the trade terms Alectro has the right to call for, or recover the Goods, and for this purpose Alectro, its agents or employees, may enter the purchasers premises or any other place where the goods may be stored, and the customer, when called upon to do so, is under an obligation to deliver up the goods to Alectro. Purchasers Rights & Remedies in Respect of Goods

Alectro agrees and acknowledges that the purchaser is entitled to all rights and remedies in respect of Goods which the purchaser has under the Trade Practices Act and similar State & Territory laws and which cannot be lawfully excluded, restricted or modified. These terms and conditions do not purport to, and do not have the effect of, excluding, restricting or modifying the exercise of any such right or remedy.

Subject always to the preceding paragraph:

- (a) All conditions, warranties and guarantees other than those expressly provided for or agreed and acknowledged by Alectro in these Terms and Conditions are excluded to the fullest extent permitted by law.

- (b) In the case of services provides; (1) the supply of services again; (2) the payment of the cost of having the services supplied again.
